**PUBLIC NOTICE IS HEREBY GIVEN** to the qualified voters of Black Hawk County, State of Iowa, that the combined city/school election will be held Tuesday, November 2, 2021.

Polls will open at 7:00 a.m. and close at 8:00 p.m. Voters must vote at their assigned precincts. Please read this notice carefully to determine your correct polling location. Voting locations have changed for some voters. All voters are required to provide an approved form of identification at the polling place before receiving and casting a ballot. Voters who are not pre-registered – such as voters registering to vote on election day – and voters who have changed precincts will additionally be required to provide proof of residence. A voter who cannot provide proof of identification may have their identity attested to by another voter registered in the precinct who has an approved form of identification. A person who is eligible to register to vote and vote, may register on election day by appearing in person at the polling place for the precinct in which the individual resides. The voter must complete a voter registration application, make written oath and provide acceptable proof of identity and acceptable proof of residence. Acceptable documents which can be used as proof of identity and proof of residence are very specific and substitutes will not be accepted. For example, identification such as a Driver's License cannot be expired. To see all forms of approved ID visit <http://sos.iowa.gov/voterid>.

**ELECTION FRAUD.** A voter commits the crime of Election Misconduct in the First Degree if the person submits false information when registering to vote. Election misconduct in the first degree is a class "D" felony, and punishable by a fine of up to \$7,500 and/or imprisonment of up to five (5) years. Individuals with felony convictions are ineligible to vote unless their rights have been restored, including those whose voting rights have been restored by Governor Kim Reynolds's Executive Order 7 of August 5, 2020. IF YOU ARE NOT 100% SURE YOUR RIGHT TO VOTE HAS ALREADY BEEN RESTORED, REQUEST A PROVISIONAL BALLOT.

**PROVISIONAL BALLOTS.** Voters who are unable to provide proof of ID/residence on election day and vote a provisional ballot must come to the courthouse to provide evidence for accepting the provisional ballot before Noon Monday, November 8.

**NOTICE IS HEREBY GIVEN** that any voter who requires assistance to vote by reason of blindness, disability, or inability to read or write may be given assistance by a person of the voter's choice, other than the voter's employer or agent of that employer or officer or agent of the voter's union.

**NOTICE IS FURTHER GIVEN**, in accordance with Chapter 49.53 of the Iowa Code that any voter who is physically unable to enter the polling place has the right to vote in the voter's vehicle.

Each polling location is equipped with a ballot marking device (ExpressVote) which may assist persons with disabilities to vote more independently. The device allows voters to make their selections using an audio read-back and touchpad, or touchscreen. The touchscreen device provides magnification and reverse black and white images. Voters unable to see the screen may have the screen turned off and use only the audio read-back and touchpad features. The audio read-back feature provides all ballot instructions, choices, and selections in an audio format using headphones.

After making selections with the ballot marking device, via touch pad or touch screen, the device will mark the voter's paper ballot and the voter will insert their marked ballot in the ballot scanner used to count all ballots. The Commissioner of Elections certifies that on Election Day all polling locations are accessible by means of permanent or temporary measures.

#### **Public Measure BM-Dunkerton School District**

**Summary:** To adopt a Revenue Purpose Statement specifying the use of revenues the Dunkerton Community School District will receive from the State of Iowa Secure an Advanced Vision for Education Fund.

**Full Text:** In the Dunkerton Community School District, the following Revenue Purpose Statement which specifies the use of revenues the Dunkerton Community School District will receive from the State of Iowa Secure an Advanced Vision for Education Fund shall be adopted.

To provide funds for property tax relief.

To provide funds to acquire or install information technology infrastructure (including improving buildings or sites for the purpose of accessing broadband digital telecommunications) and school safety and security infrastructure.

To provide funds to build and furnish a new school building or buildings; to build and furnish addition(s) to school buildings in the District; to remodel, reconstruct, repair, expand, and improve the school buildings in the District; to purchase and improve grounds; for demolition work; to furnish and equip district facilities.

To provide funds for the purchase, lease or lease-purchase of buildings, equipment (including transportation and recreation equipment), or technology and to repair transportation equipment for transporting students as authorized by law, to implement energy conservation measures, sharing or rental of facilities including a joint infrastructure project for the purpose of offering classes under a district-to-community college sharing agreement as authorized in Iowa Code Section 423F.3(3)(c), procuring or acquisition of libraries, or opening roads to schoolhouses or buildings.

To provide funds to purchase land as part of start-up costs for new student construction program or if the sale of the previous student construction was insufficient to purchase land, and to purchase construction materials and supplies for a student-constructed building or shed intended to be retained by and used by the District. To provide funds to make payments to a municipality or other entity as required under Iowa Code Section 403.19(2).

To provide funds for demolition, cleanup, and other costs if such costs are necessitated by, and incurred within two years of, a disaster.

To provide funds to establish and maintain public recreation places and playgrounds; provide for supervision and instruction for recreational activities; or for community education purposes.

To provide funds for the payment of principal and interest or retirement of general obligation bonds issued for school infrastructure purposes, energy improvement loans, loan agreements authorized by Iowa Code Section 297.36, sales, service and use tax revenue bonds issued under Iowa Code Section 423E.5 or Iowa Code Section 423F.4; and

To provide funds for other authorized expenditures and purposes as now or hereafter permitted by law and designated by the Dunkerton Community School District.

It being understood that if this proposition should fail to be approved by the voters, such failure shall not be construed to terminate or restrict authority previously granted by the voters to expend receipts from the Secure an Advanced Vision for Education Fund.

If approved, this Revenue Purpose Statement shall remain in effect until replaced or amended by the Dunkerton Community School District.

Iowa Code Section 423F.3(3)(b)(2)(a) Notice:

If a majority of eligible electors voting on the question fail to approve this Revenue Purpose Statement, then upon expiration of the current Revenue Purpose Statement, revenues received by the School District from the Secure an Advanced Vision for Education fund shall be expended in the following order:

The payment of bonds for which SAVE Revenue has been pledged;

Reduction of bond levies under Iowa Code Sections 298.18 and 298.18A and all other debt levies;

Reduction of the regular and voter-approved physical plant and equipment levy under Iowa Code Section 298.2;

Reduction of the public educational and recreational levy under Iowa Code Section 300.2;

For any authorized infrastructure purpose of the school district as defined in Iowa Code Section 423F.3(6); and

For the payment of principal and interest on bonds issued under Iowa Code Sections 423E.5 and 423F.4.

**Public Measure BY-Wapsie Valley School District**
